Dear Ambassador,

Thank you for Ukraine's participation at the 2023 OECD Council Meeting at Ministerial Level this week. We were very honoured to have Prime Minister, H.E. Mr. Denys Shmyhal, the Minister of Energy, H.E. Mr. German Galushchenko, Deputy Minister of Economy and Trade Representative, Mr. Taras Kachka, and yourself join us.

I am writing in relation to the OECD assessed contributions and partnership fees for Ukraine in 2023. The OECD Council has acknowledged the extraordinary hardship confronting Ukraine in the context of Russia's war of aggression. As a signal from the OECD Members to Ukraine of political and financial support in this exceptional situation, Council has authorised the Organisation to apply part of the 2022 Part I Budget net results to the payment of Ukraine's 2023 assessed contributions and partnership fees, whether under Part I or Part II of the Budget.

The decision of the Council means that Ukraine's 2023 assessed contributions and partnership fees will be covered by the Organisation and its Members and will not have to be paid by Ukraine. Please find attached an indicative list of Ukraine's 2023 assessed contributions and partnership fees within the scope of the Council decision.

Ukraine has our continued strong solidarity and support, and I look forward to continuing and deepening our cooperation through the Ukraine Country Programme.
